A fee of \$25.00 will be levied for a returned check. All entries must be submitted on Official UKC entry forms, one dog per entry form. Unsigned, incomplete or illegible entries are not acceptable and will not be entered in the trial. Faxed entries and/or credit card payments cannot be accepted. Entries sent by overnight mail must not require a signature. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by judge or veterinarian, barred from competition by action of the show committee or UKC. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency or any other cause beyond the control of the show committee. Refunds will be given for bitches that come in season after the closing date of the trial minus a \$5.00 handling fee with a veterinarian's certificate prior to the start of the trial.

This is a tentative running order. It is subject to change or adjustment based on the actual number of entries received at each level. Masters and Elite will not start before noon each day. A final running order will be sent via email with a final confirmation and trial instructions.

Trial Information

To encourage pre-entries, if you do not pass the required PT test in the morning the club will refund you the element trial entry fees that were pre-paid. Refunds will be sent via mail within 10 days of the trial.

Move-ups will be allowed. Move-ups for Saturday's and Sunday's Trial 1 must be received by the Trial Secretary by Tuesday, May 30, 2017. No move-ups for Trial 1 either day will be accepted the day of the trial. Move-ups between Trial 1 and Trial 2 will be allowed each day. Instructions for the move-up procedure between trials will be given at the judge's briefing.

Crating space will not be available indoors and handlers will need to plan to work from vehicles.

Lunch will be available for purchase however it will be by pre-order only. Ordering information will be provided in the final trial confirmation instructions.

Notice to Exhibitors

A UKC PT or NACSW ORT is required for entry in a UKC element title trial for the level/odor entered. Copy of PT or ORT should be sent with entry.

“A” Section Classes - This section is open to all exhibitors and dogs that have not earned a title in the element in which they are entering or equivalent title in another organization. The exhibitor must own the dog entered or be a member of the owner’s household or immediate family. Once the dog has earned the title they may no longer compete in the “A” section. No licensed or professional dog trainer or Nosework instructor, regardless of the person’s status as an amateur or professional, may compete in this section. No person licensed to officiate Nosework in UKC or any other organization may compete in this section.

Exhibitors with more than one dog entered in a trial. Exhibitors may handle only one dog in each class, or element in each trial. An exhibitor may enter more than one dog in the same class or element so long as a separate handler is provided for each dog. Exhibitors may enter and handle more than one dog per trial provided the additional dog(s) are entered in a different class or element from all other entries being handled by that exhibitor.

A UKC registration number is required to participate in these trials. For information on UKC registration go to www.ukcdogs.com.

Awards and Prizes:

Placement ribbons will be provided for 1-4 placements in each class. Blue qualifying ribbons will be awarded to all dogs receiving a qualifying score. Ribbons will be provided for High in Trial for each trial at each level. A High Junior ribbon will be awarded for each trial for each level. New title ribbons will be offered for anyone earning a new element titles. Rosettes will also be offered for those individuals completing their full level titles.

Directions to Facility:

Competitor parking will be in the Horticulture Building Parking Lot on the Kirkwood Community College Campus:

All of Kirkwood Community College Campus has the same address: 6301 Kirkwood Blvd SW, Cedar Rapids, IA. You can use that address with GPS to get to the general vicinity, but the address will not take you to the trial site on the campus. These GPS coordinates should get you to the trial site: 41.906561, -91.649392 Trial participant parking is a large paved lot in front of the Horticulture/Floral Careers building. There are grassy areas all around the perimeter. There will be plenty of room for all, including pop-ups, RVs (but no hookups) etc.

Interstate 380 northbound

Take exit 13, Eastern Iowa Airport/Ely.

At the stop light, turn right (east) onto Wright Brothers Blvd.

At the first stop sign, turn left at Kirkwood Blvd. SW (north). Travel just short of one mile to the stop light.

At the stop light, turn right (east) onto 76th Avenue Dr. SW. Travel about 1/4 mile. You will see a gray concrete block building, the Animal Health Center on your left. Turn left at the unmarked campus road immediately past the Animal Health Center.

Turn into the 2nd driveway on your left, just before the bus stop shelter to access trial participant parking.

Interstate 380 southbound

Take exit 16 for Highway 30 and Kirkwood Community College. Bear left onto the ramp for Highway 30 eastbound and Kirkwood Community College.

Once you have crossed over the interstate, bear right to avoid the on-ramp to Highway 30 eastbound.

At the stop light, turn right (east) onto Kirkwood Blvd. SW (north). Travel one and a half miles.

At the stop light, turn left (east) onto 76th Avenue Dr. SW. Travel about 1/4 mile. You will see a gray concrete block building, the Animal Health Center on your left. Turn left at the unmarked campus road immediately past the Animal Health Center.

Turn into the 2nd driveway on your left, just before the bus stop shelter to access trial participant parking.

Highway 30 eastbound or westbound

Take exit 253, Kirkwood Blvd. SW/Bowling St.

At the stop light, go left on Kirkwood Blvd. SW (south). Travel one and a half miles.

At the stop light, turn left (east) onto 76th Avenue Dr. SW. Travel about 1/4 mile. You will see a gray concrete block building, the Animal Health Center on your left. Turn left at the unmarked campus road immediately past the Animal Health Center.

Turn into the 2nd driveway on your left, just before the bus stop shelter to access trial participant parking.
