SHOW SITE WILL BE AVAILABLE FOR SET UP AT 7 AM Saturday & Sunday .. The building will be closed and dogs must be removed from the show site each trial within 30 minutes of the completion of judging.

Ring size will be according to AKC Regulations.

Please leave the motel and motel grounds clean. Any complaints from proprietors will be handled by the Show Committee.

Telephone, email and unsigned entries cannot be accepted. Entries not on an Official AKC Entry Form and photocopies of entry forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

Make all checks and money orders payable to Iowa City Dog Obedience Club. Canadian exhibitors must make fees payable in US funds. Payment must accompany entries.

Mail all entries to Deb Owens, 508 2nd Ave, Luther, IA 50152. Entries received without fees will not be accepted. Acknowledgement of entries will be made as soon as practical. Unless an exhibitor specifically requests postal communication, submission of an email address on the entry form will serve as authorization to send communication, including entry confirmation via email. It is the exhibitor's responsibility to ensure that their email software will accept messages from ICDOCobsecretary@gmail.com

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by veterinarian or judge, or barred from competition by action of Show Committee or AKC. The well-being of dogs, exhibitors and spectators is of paramount importance, and in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

ICDOC does not agree to arbitrate claims as set forth on the Official AKC Entry Form for these events.

Owners are responsible for errors on completed entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

Post-dated and returned checks do not constitute a valid entry. A collection fee will be added to the amount of each returned check.

No refund for duplicate entries. Care will be taken to find duplicates, however, if an entry has been processed, no refund will be made.

No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee be asked to leave the trial site. There will be no refunds of entry fees if a person is asked to leave the trial site.

Dogs may arrive any time prior to their scheduled judging. Dogs not required for further judging may be excused. Judges will not wait for any dog holding up a class. Owners or agents are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

Class prizes will be distributed in the ring to the person showing the dog. Claims must be made in the ring before the judging for that show is over, and the Secretary advised at once. All prizes must be claimed at the show. If not, they become the property of ICDOC. No prizes will be mailed.

ICDOC, the show secretary, members of the show committee, their agents, employees, etc. assume no responsibility for any loss, damage or injury sustained by spectators, exhibitors, handlers, their employees or children, etc. or to any of their dogs or property.
